- 7. Bids shall be opened in the presence of Bidders' representatives who choose to attend 13:00 hrs of 31st day from the first date of publication *at* the office of Ministry of Finance. Bids must be valid for a period of *90 days* counting from the day of bid opening and must be accompanied by bid security as mentioned below(which shall be *valid for minimum 30 days* beyond the bid validity period.)
- 8. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
