- have sufficient English or Chinese proficiency which meets the academic requirements of the program. English: IELTS 6.0 or above, Chinese: HSK level 4 (score 180) or above, or other evidence which indicates your English or Chinese proficiency is adequate.

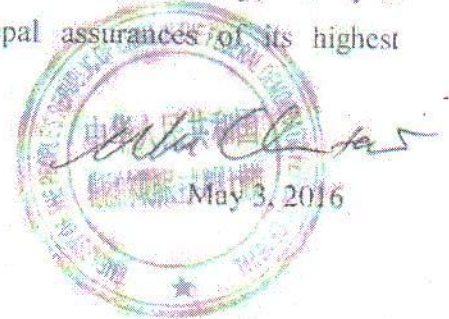
