The Ministry of Finance, Government of Nepal ("the Employer") invites sealed bids from eligible Bidders for: Supply, Delivery, Installation and Commissioning of IT Equipment for Debt Operation & Management Software (DOMS). Only eligible bidders with the following key qualifications should participate:

Successful completion as main supplier within the last 3 years, of at least 1 contract valued at NPR 25 Million

Average annual turnover of NPR 100 Million within the last 3 years

National Competitive Bidding will be conducted in accordance with ADB's 'Single-Stage: Two Envelope' Bidding Procedure and is open to all Bidders from eligible countries as described in the Bidding Document.

- ii. pay a non-refundable fee of NPR 5,000.00 (Nepalese Rupee Five Thousand Only) by cash/ cashier'scheck in favor of Ministry of Finance. If the Bidder desires to have the Bidding Document sent to him by courier to an address outside Kathmandu, the Bidder shall pay an additional amount of NPR 20,000.00 (Nepalese Rupee Twenty-five thousand only) for cost of courier at the time of making the application.
